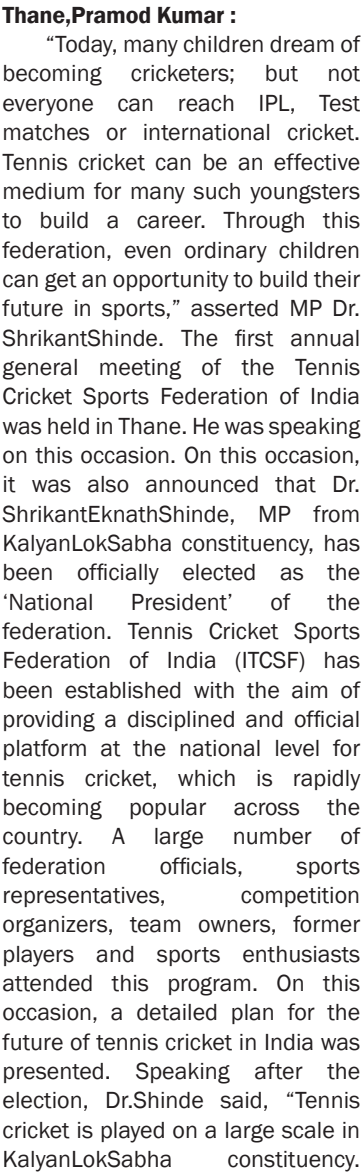

*The first annual general meeting of the Tennis Cricket Sports Federation of India concluded
MP Dr.Shrikant Eknath Shinde elected as the 'National President' of the Federation*



This competition is the only competition in the entire Thane district and was carried out by Runners Clan Foundation with great responsibility. After the unprecedented success of the 65 km urban ultra marathon from Gateway of India to Dombivli under the theme "EkDaud Veer JawaanKeLiye" for the last five years, Runners Clan Foundation took up the baton of the 12-hour stadium run for the first time and successfully completed it. The organization distributed incentive prizes to the winning competitors by the hands of local MLA and BJP Maharashtra State President RavindraChavan. Vishal Valvi won the first prize in the 12-hour solo run, SujataShahu in the women's, RamdasMestri in the 6-hour solo run, Rani Singh in the solo women's and KDR's team came first in the relay. Finally, GirishLokhande, the working president of the organization, thanked all the attendees.

Shrikant Eknath Shinde, MP from Kalyan Lok Sabha constituency, has been officially elected as the 'National President' of the federation. Tennis Cricket Sports Federation of India (ITCSF) has been established with the aim of providing a disciplined and official platform at the national level for tennis cricket, which is rapidly becoming popular across the country. A large number of federation officials, sports representatives, competition organizers, team owners, former players and sports enthusiasts attended this program. On this occasion, a detailed plan for the future of tennis cricket in India was presented. Speaking after the election, Dr. Shinde said, "Tennis cricket is played on a large scale in Kalyan Lok Sabha constituency.

Many big tournaments are organized here. Through tennis cricket, a boy from an ordinary family can make himself a cricketer. For those players who cannot play cricket at a professional level, this is an independent and capable platform." He further said, "Our government has also taken the step of giving professional status to traditional games like Govinda-Dahihandi through 'Pro-Govinda'. A game that was played only once a year has also been given a platform, recognition and recognition. Similarly, Kabaddi has reached the national and international level today through 'Pro-Kabaddi'. That is, our government has taken the role of giving priority to every game. Tennis cricket is already at a different level, and the Federation will continuously try to give it a

professionally capable form.” 125 to 150 tournaments are organized through the Federation every year, and about 40 to 45 lakh players participate in these tournaments. The total prize money of these tournaments is approximately around Rs 30 crore. It was clarified that the organizers and the federation are working to provide a proper platform to the players. Due to the rapid growth and increasing financial investment in tennis cricket, the attraction of the youth towards this sport has increased to a great extent. However, due to the lack of any official control mechanism, there was a picture of malpractices and problems arising in some places. Against this backdrop, competition organizers, experienced players, sponsors and team owners from all over the

country came together to form the Tennis Cricket Sports Federation of India. The federation was started in 2022, and in August 2025, the federation was officially registered on the lines of BCCI under Section 8 of the Companies Act. Currently, representatives from the states of Maharashtra, Gujarat, Rajasthan, Haryana, Delhi NCR, Uttarakhand, Uttar Pradesh, Bihar, Chhattisgarh, Madhya Pradesh, Karnataka, Goa, Tamil Nadu and West Bengal are participating in the federation. The federation will be expanded to other states in the coming days. The determination to give a new direction to the dreams of many youth to become cricketers by giving a disciplined, transparent and professional form to tennis cricket was expressed in this very first meeting.

Kolkata,(Agencies) :

The Azzurri are at a World Cup again. No, not that one hosted by FIFA — this time, it's the ICC Men's T20 World Cup.And even if it involves bats instead of boots, the Italian sporting family is showing up all the same. Italian football royalty Andrea Pirlo and Christian Vieri have sent messages of support to the Italy men's cricket team as they prepare for their maiden T20 World Cup campaign.The crossover might feel unexpected, but the enthusiasm is unmistakable.Pirlo — 2006 World Cup winner, cultured midfield maestro and scion of a steel empire — appeared to wish the cricketers luck.Christian Vieri, a known admirer of Australian great Allan Border, also sent a personal message to the Italian squad in India and Sri Lanka ahead of the tournament.The



message underlined a growing effort by Italian sports' powerbrokers to rally support beyond football, and to earn cricket on the national radar. Italy earned their spot at the expanded 20-team T20 World Cup by finishing second behind the Netherlands in European qualifying. Along the way, they made history, beating Ireland for the first time – their maiden victory over a full ICC member. While the Italian football team still waits to secure qualification for the next FIFA World Cup, the cricket side is riding a

have of confidence. Recent wins over Canada and others have turned heads, and qualification ahead of higher-ranked nations has raised eyebrows across Europe. Drawn in the same group as England, Italy know an upset would be monumental. But they'll quietly fancy their chances. Italians, after all, have a long tradition of unsettling the English on big stages. Behind the scenes, the Italian Cricket Federation is thinking bigger. According to federation official Bruno Malaspina, talks are underway with the proposed European T20 Premier League about launching an Italian franchise, potentially by 2027. Grassroots plans are also in motion, with cricket set to be introduced in schools to inspire the next generation. Italy begin their World Cup journey against Scotland in Kolkata on Monday.


Tehran, (Agencies) : Iran's Supreme Leader Ayatollah Ali Khamenei has, for the first time in 37 years, skipped the annual February 8 meeting with air force commanders, a longstanding ritual he has observed every year since assuming power in 1989. The absence comes at a sensitive moment as tensions between Iran and the United States escalate, fuelling speculation over Tehran's next moves amid fears of a possible US military strike. The annual gathering is a symbolic display of loyalty to the Islamic Republic and has been a fixture on Iran's military calendar for nearly four decades. This year, however, Khamenei did not attend. Instead, Armed Forces Chief of Staff Abdolrahman Mousavi met senior air force officers on his behalf. Khamenei's decision to stay away has drawn attention given the broader geopolitical context. The Iranian leader has repeatedly warned that any



US attack would trigger a wider regional conflict, saying such a move would "spill over across the entire region." For decades, Khamenei has overseen Iran's response to multiple regional confrontations and proxy wars, consolidating his authority as the country's ultimate decision-maker. His absence from a ceremonial event politically significant to the regime has therefore sparked

debate among observers. Analysts say the move could signal a calculated shift, suggesting Iran's leadership may be prioritising strategic restraint over symbolic shows of strength. It may also point to internal deliberations within Iran's power structure on how to manage pressure from Washington, balancing diplomatic engagement with military deterrence. The

development comes against the backdrop of recent nuclear talks between Iran and the United States in Oman, which Iranian officials described as a "good start" despite deep differences over Tehran's missile programme and regional policies. Iran has, however, reiterated that it will continue nuclear enrichment and that no external power can prevent it from doing so.

1. The Company is a Non-Deposit taking Non Banking Financial Company (NBFC) registered with Reserve Bank of India and classified as Base Layer NBFC (NBFC-BL) in accordance with the Reserve Bank of India (Non-Banking Financial Companies – Registration, Exemptions and Framework for Scale Based Regulation) Directions, 2025.

2. The above financial results for the quarter and nine months ended 31st December, 2025 have been reviewed by the Audit Committee and on its recommendation approved by the Board of Directors at their respective meeting held on 09th February, 2026. The Statutory Auditors of the Company have expressed an unmodified opinion based on their limited review of unaudited financial results for the quarter and nine months ended 31st December, 2025.

3. The above financial results of the Company have been prepared in accordance with Indian Accounting Standards (‘Ind AS’) as prescribed under Section 133 of the Companies Act, 2013, read with the Companies (Indian Accounting Standards) Rules, 2015 (as amended) and the other accounting principles generally accepted in India and in compliance with Regulation 33 and Regulation 52 read with Regulation 63(2) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“ the SEBI Listing Regulations ”), as amended.

4. The Company is operating in a single reportable segment i.e. Non Banking Financial Activities . All activities are carried out within India. As such there are no separate reportable segments as per Indian Accounting Standard -108 (Ind AS) "Operating Segments".

5. During the quarter ended 31st December, 2025, the Company has further issued 1,000 fully paid, senior, secured, rated, listed, redeemable, taxable non-convertible debentures (“NCDs”), each having a face value ₹ 1,00,000/- (Rupees One Lakh Only) aggregating to ₹ 1,000 Lakhs (Rupees One Thousand Lakhs Only), at par thereby, the total outstanding NCDs as at 31st December, 2025 aggregating to ₹ 5,000 Lakhs (Rupees Five Thousand Lakhs Only). All the outstanding NCDs are listed on BSE Limited and are fully secured by exclusive, current and continuing charge by way of hypothecation over the specified receivables of the Company to the extent of 125% of the outstanding amount of the NCDs (including Interest), as detailed out in Information Memorandums and the Company has maintained the requisite security cover which is sufficient to discharge the outstanding principal and interest amount at all time for NCDs. Security Cover certificate as per regulation 54 read with regulation 56(1)(d) of the SEBI Listing Regulations and compliance with the Financial Covenants certificate in respect of the outstanding NCDs have been separately filed with BSE Limited.


6. In respect of NCDs issued and outstanding by the Company as stated in Note 5 above, the statement of disclosure of line items in accordance with Regulation 52(4) of the SEBI Listing Regulations has been separately filed with BSE Limited.

7. The Company has no subsidiary/associate/joint venture company(ies) during the above reporting period, hence the applicability to prepare consolidated financial results is not applicable to the Company.

8. The Government of India has notified four new labour codes (“Labour Codes”) on 21st November, 2025, thereby rationalising 29 existing labour laws into a comprehensive and unified framework. The Ministry of Labour and Employment has issued draft Central Rules and FAQs to facilitate assessment of the financial impact due to changes in the regulations. Among the other changes, the Labour Code provide a unified definition of “wages” to be applied across various employee benefit computations. Based on management’s initial assessment, considering the best information available, there is no financial impact due to changes in the Regulation on the Company. The Company continues to monitor the finalisation of Central /State rules and related clarifications from the Government on the Labour Codes and will provide appropriate accounting effects based on such developments, as needed.

9. The financial results of the Company have been prepared in accordance with Regulation 33 and Regulation 52 read with Regulation 63(2) of the SEBI Listing Regulations and will be available on the website of the Company (www.mangalfincorp.com) and the Stock Exchanges i.e. BSE Limited (www.bseindia.com) and National Stock Exchange of India Limited (www.nseindia.com).

10. Previous periods/year's figures have been regrouped / reclassified, wherever necessary, to make them comparable with the figures of the current period.
