Proceedings of the 59th Annual General Meeting of Mangal Credit and Fincorp Limited ("the Company")

The 59th Annual General Meeting ("AGM") of the Members of the Company was held on Wednesday, 29th September, 2021 at 11:00 a.m. through Video Conferencing/ Other Audio Visual Means without physical presence of the Members at a common venue.

It was informed to the Members that in view of the social distancing norms to be followed due to the COVID-19 pandemic, the AGM was conducted through VC in compliance with the provisions of Companies Act 2013, the circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India ("SEBI"). The Chairman further informed the Members that the Company had engaged the services of Central Depository Services (India) Limited ("CDSL") for providing the facility for participation in the AGM through VC and for electronic voting on matters set out in the notice convening the AGM ("AGM Notice").

Mr. Meghraj Jain, Chairman and Managing Director of the Company occupied the chair and welcomed the Members, fellow Directors and colleagues joining the Meeting through VC. He then introduced Board of Directors to the Members. Mr. A. Ramanathan had expressed his inability to attend the AGM.

The representative of M/s. MGB & Co. LLP, Statutory Auditor and M/s. Vijay Tiwari & Associates, the Secretarial Auditor of the Company were attending the AGM through VC.

The Chairman informed the Members that since the requirement of physical presence of the Members at a common venue has been dispensed with, the Company had made all efforts feasible under the prevailing circumstances to enable the Members to participate in the AGM through VC and vote electronically.

The requisite quorum being present, the Chairman called the Meeting to order. 41 Members representing 58,89,049 equity shares of the Company had joined the AGM.

The Company Secretary informed the Members that facility for Remote e-voting on the resolutions set out in the AGM Notice was provided to the members of the Company whose names appeared in the records of the Company as on cut-off date Wednesday, 22nd September, 2021. Remote e-voting commenced on Sunday, 26th September 2021 at 09:00 am. and ended on Tuesday, 28th September 2021 at 05:00 pm. The Company Secretary further stated that Members present in the Meeting who had not cast their vote through remote evoting facility can cast their vote through the e-voting system provided by CDSL which was open for voting till 15 minutes from the time of closure of the AGM.

The Chairman informed the Members that the Register of Directors and Key Managerial Personnel and their Shareholding, Register of Contracts with related party in which directors are interested and all the other documents referred to in the Notice convening the 59th AGM ("AGM Notice") were available for online inspection by the Members during the continuance of the AGM and that Members seeking to inspect such documents could send an email to the Company Secretary and Compliance Officer at compliance@mangalfincorp.com.

The AGM Notice which was dispatched by permitted mode was taken as read.

The Chairman informed the Members that the Audit Report on the Financial Statements for the financial year ended 31st March 2021, did not contain any qualifications, reservations, adverse remarks or disclaimers.

The Chairman informed the Members that since the resolutions set out in Notice of Annual General Meeting have already been put to vote through e-voting, the resolutions need not be proposed or seconded by shareholders at the meeting.

The Chairman requested Ms. Supriya Agarwal, Company Secretary and Compliance Officer of the Company to apprise the Members on the following business items as set out in the AGM Notice which were transacted at the AGM:

Ordinary Business:

- 1. To receive, consider and adopt the Annual Audited Financial Statements of the Company for the financial year ended 31st March, 2021 along with the reports of the Board of Directors and Statutory Auditors thereon Ordinary Resolution;
- 2. To declare the final dividend on equity shares for the financial year ended 31st March, 2021 Ordinary Resolution;
- 3. To appoint a Director in place of Mr. Meghraj S. Jain (DIN:01311041), who retires by rotation and being eligible, offers himself for re-appointment **Ordinary Resolution**;

4. To appoint a Director in place of Mr. Naval Maniyar (DIN: 06657440), who retires by rotation and being eligible, offers himself for re-appointment - Ordinary Resolution;
