An average of 109 incidents of rape against women in Maharashtra NCRB report



109 cases; January to June 2022, 22,843, 126 incidents; July to December 2022, 20,830, 116 incidents; 2023, 45,434, 126 incidents.

Mumbai, Dinesh Singh: The general public is outraged when there is a large number of cases of violence against women from all over the state. In this background, if we study the statistics of the National Crime Records Bureau (NCRB), it is noticed that the daily average number of incidents during the era of MahavikasAghadi and Mahayutti is 126. Even in 2021, there were 109 cases of rape of women every day in Maharashtra. Interestingly, from January to June 2022, an average of 126 incidents were occurring per day, which is the same number of incidents as 126 per day. The Badlapur incident and the subsequent agitation by the Maha Vikas Aghadi, the reactions of most of the political leaders on a daily basis, have stirred up the general public. An NCRB analysis reveals that 31,701 women were raped in Maharashtra in 2020, an average of 88 incidents per day. 2021 was also the year. The number of incidents of rape against women in Maharashtra has suddenly reached 39,266 this year. This comes to an average of 109 incidents per day. From January to June 2022, a total of 22,843 incidents of violence against women took place during the Mahavikas Aghadi period. Its average is 126 incidents per day. On June 30, 2022, the grand coalition government came. 20,830 incidents took place in the 6 months from July to December 2022. This comes to an average of 116 incidents per day. Now in 2023 there will be 2022 incidents, the average of which also comes to 126 incidents per day. This means that during the Covid era, when Uddhav Thackeray was the Chief Minister, the same number of incidents are happening in Maharashtra today. Overall, the number of incidents of violence against women is the same as during MAHAVIKAS AGHADI time. In this too, if we look at the crimes under the category of attempted rape of minor girls (POCSO Section 12, IPC 509), there has been a sudden increase from 2021 onwards. These crimes were 94 in 2017, 48 in 2018, 94 in 2019, 48 in 2020. It suddenly increased from 2021 and the number reached 249. In 2022, this number will be 332. Out of this, till June 2022, the state had a Mahavikas Aghadi government led by Uddhav Thackeray and Anil Deshmukh as the Home Minister. While this trend is seen on the one hand, the number of molestation cases in the case of girls above 18 years of age has decreased. In 2022, during the Mahavikas Aghadi government, 1317 crimes were reported, it was reported as 1208 in 2023. IPC 354 crime against women has a pattern of increase. The number increases to around 700 to 900 every year. But, at the same time, there is also a decrease in some categories of crimes.

The number of cyber crimes related to women which went up to 116 in 2022, has come down to 79 in 2023. In the case of Mumbai, cases of rape registered under Sections 4 and 6 of POCSO have reduced. Also, 445 rapes took place in Mumbai in 2020. In 2021, 524 minor girls were raped. In 2022 this number increased to 615, while in 2023 it decreased to 590. 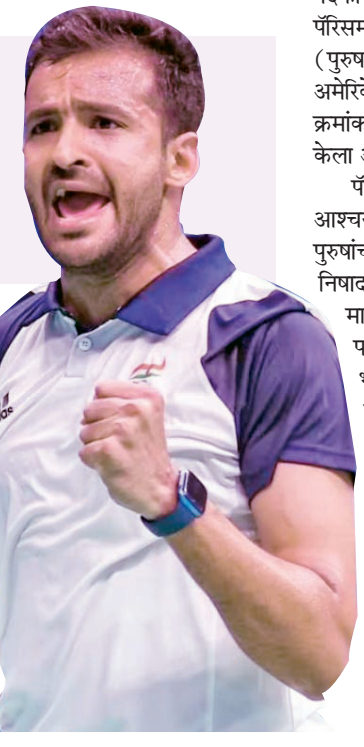
